Fees for Dependents of Expats in the Kingdom of Saudi Arabia


The Philippine Overseas Labor Office (POLO) in Riyadh, Kingdom of Saudi Arabia reported that the Saudi Ministry of Communications and Information Technology announced through Arab News, that starting 01 July 2017, foreign workers in the Kingdom have to pay to the General Directorate of Passport the amount of SR 100 (USD 27) per month for each dependent living with them in KSA.

The POLO further cited in the said report that:

1. Dependents include wife (or wives), children, parents, wife's father or mother, house workers, and drivers who are registered under the name of the expat working in commercial companies;
2. The fee will be increased to SR 200 (USD 53) per dependent per month in 2018, SR 300 (USD 80) per month in 2019 and SR 400 (USD 107) in 2020;
3. The General Directorate of Passports of the Ministry of Interior (MOI) said that the issuance of exit/ re-entry visas for expatriate and the renewal of residence permits will not be made unless the dependents' fees are paid in advance; and
4. Government agencies including banks are updating their technical platforms for accepting these fees.
