of their Visa and Overseas Exit Clearance/E-receipts and payment of Airline Ticket.

The Korean Embassy has issued an instruction on the need to submit the NBI Clearance, valid for three (3) months from date of issuance, when applying for a Korean visa.

Please be advised that sixteen **(16) Sincere workers** were denied entry to Korea and sent back to the Philippines on that same day due to passport forgery.
