After release of clearance, please proceed to the Guard-on-Duty to get a schedule for Step 2 NHAD approval, encoding, releasing, payment of POEA processing fee (PhP equivalent of US\$100.00) and OWWA membership (PhP equivalent of US\$25.00). For workers who were processed at the POEA Regional Offices, your clearances shall be sent through the POEA Regional and Overseas Coordinating Office.
