Above stated workers may proceed to your respective Regional Centers or Regional Extension Units, or at Window 6, Second Floor, Name Hire Assistance Division, Landbased Center from Monday to Friday, 8:00 a.m. to 4:00 p.m. to claim your respective clearances. Please bring original copies of your documents. After release of clearance, please proceed to the Guard-on-Duty to get a schedule for Step 2 NHAD approval, encoding, releasing, payment of POEA processing fee (Php equivalent of US\$100.00) and OWWA membership (Php equivalent of US\$25.00). For workers who were processed at the POEA Regional Offices, your clearances shall be sent through the POEA Regional and Overseas Coordinating Office.

However, Domestic Workers and Live-in Caregivers whose age falls below the minimum age requirement (23 years old) as provided for by Governing Board Resolution No. 04, Series of 2006 cannot be cleared for deployment due to aforementioned reason.
