Above stated workers may proceed to your respective Regional Centers or Regional Extension Units, or at Window 6, Second Floor, Direct Hire Assistance Division, Landbased Center from Monday to Friday, 8:00 a.m. to 4:00 p.m. to claim your respective clearances. Please bring original copies of your documents. After release of clearance, please proceed to the Guard-on-Duty to get a schedule for Step 2 DHAD approval, encoding, releasing, payment of POEA processing fee (PhP equivalent of US\$100.00) and OWWA membership (PhP equivalent of US\$25.00). For workers who were processed at the POEA Regional Offices, your clearances shall be sent through the POEA Regional and Overseas Coordinating Office.

B. The POEA Direct Hire Assistance Division (DHAD) likewise serves notice to the following workers with DENIED application for DOLE Clearance from the ban on direct hiring:

Above workers and their employers are advised to find a Philippine Recruitment Agency (PRA) to undertake the processing and issuance of their respective Overseas Employment Certificates (OECs) which serves as worker's travel exit clearance.

Please log on to www.poea.gov.ph for the complete list of licensed PRAs from which your employer may choose from: (ONLINE SERVICES → VERIFICATION OF AGENCY'S JOB ORDERS → SEARCH AVAILABLE JOB ORDERS BY COUNTRY → "SORT BY AGENCY" → SELECT COUNTRY OF DESTINATION → SUBMIT.

However, Domestic Workers and Live-in Caregivers whose age falls below the minimum age requirement (23 years old) as provided for by Governing Board Resolution No. 04, Series of 2006 cannot be cleared for deployment due to aforesaid reason.
