Above stated workers may proceed to your respective Regional Centers or Regional Extension Units, or at Window 6, Second Floor, Direct Hire Assistance Division, Landbased Center from Monday to Friday, 8:00 a.m. to 4:00 p.m. to claim your respective clearances. Please bring original copies of your documents. After release of clearance, please proceed to the Guard-on-Duty to get a schedule for Step 2 DHAD approval, encoding, releasing, payment of POEA processing fee (PhP equivalent of US\$100.00) and OWWA membership (PhP equivalent of US\$25.00). For workers who were processed at the POEA Regional Offices, your clearances shall be sent through the POEA Regional and Overseas Coordinating Office.
