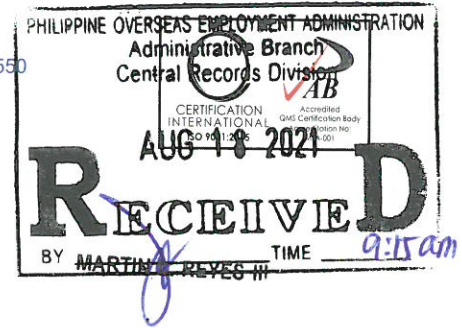

TRAVEL RESTRICTIONS OF FOREIGN NATIONALS INTO THAILAND

Thailand's Regulation issued under Section 9 of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005) (No 13), "Non-Thai nationals who have a work permit or have been granted permission from government agencies to work in the Kingdom of Thailand, including their spouses and children" are allowed to enter the country. However, subject travelers must strictly comply with the following measures:

Prior to travelling into Thailand

1. Avoid travelling into a COVID-19 affected area or communities at least 14 days before travelling
2. Required documents;
 - Passport
 - Certificate of Entry (COE)
 - Fit to Fly Certificate
 - Certificate of COVID-19 Free (issued no more than 72 hours before travelling)
 - Health insurance covering COVID-19 (not less than 100,000 US dollars)
 - Letter of approval on quarantine accommodation by Thai authorities.
3. Exit Screening

Arriving and while being in the country

1. Entry Screening
2. Submit the required documents
3. Download the tracing mobile phone app
4. Enter a 14-day local or state quarantine
5. Be tested for COVID-19 by RT-PCR twice

We would also like to inform the public that the Thailand Government has extended its lockdown measures for 14 days which started last August 3, 2021. The number of

provinces, classified as dark-red zones under strict enforcement of maximum COVID-19 controls, increases from 13 to 29. The measures allow stores to sell food for delivery only, while the curfew period remains unchanged. Branches of commercial banks located in department stores will remain closed, while sales and consumption of alcoholic beverages is still prohibited at this time.

The lockdown measures become effective on August 3rd and continue until August 18th. However, the Center for COVID-19 Situation Administration (CCSA) says that if the situation does not improve, they may be extended until August 31st.
