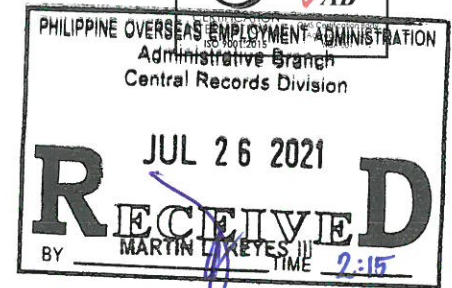

**Reminders to Departing Overseas Filipino Workers (OFWs)**  
*Paalaala sa mga Paalis na OFWs*  
**During the COVID-19 Worldwide Pandemic**  
*sa Panahon ng COVID-19 Pandemic*

After the issuance of Overseas Employment Certificates (OECs), the OFWs are advised to:

*Pagkatapos na maipagkaloob ang Overseas Employment Certificates (OECs), ang mga OFW ay pinapayuhan sa mga sumusunod:*

1. Check the confirmation or cancellation of flights;  
*Alamin at tiyakin kung kumpirmado o kanselado ang inyong flights;*
2. Monitor the status of entry regulations in their country/ies of destination. Due to the surge of COVID-19 infection, each country of destination may decide to restrict the entry of foreign nationals, including Filipinos, without any prior notice;  
*Subaybayan ang mga kasalukuyang regulasyon ukol sa pagpapapasok sa bansang patutunguhan. Dahil sa pagtaas ng kaso ng COVID-19, ang bawat bansa ay maaaring maghigpit sa pagpapapasok ng mga dayuhan, kasama na ang mga Filipino, kahit na walang paunang abiso;*
3. Comply strictly with security restrictions, visa regulations, health and quarantine protocols in the Philippines, transit country/ies and country of destination;  
*Sumunod sa mga alituntuning pang-seguridad, regulasyon sa visa, mga protocol para sa pangkalusugan at quarantine dito sa Pilipinas, sa bansang pagdadaan at bansang patutunguhan;*
4. Be in possession of appropriate COVID-19 RT-PCR test result and/or antigen test results as appropriate, for ready reference when required in ports of entry;  
*Dapat panghawakan ang mga kaukulang resulta ng COVID-19 RT PCR test o ang resulta ng antigen test para agad maipakita sa mga kainauukulan kung kinakailangan;*
5. Be in possession of proof of full vaccination for ready reference, when required; and  
*Panghawakan ang katibayan ng inyong pagpapabakuna para agad na maipakita kung kinakailangan; at*

6. Be guided by official advisories provided by the Philippine government as well as those of the country of work destination.

*Sumangguni sa mga opisyal na pahayag mula sa gobyerno ng Pilipinas at ng bansang patutunguhan.*

Agencies deploying newly-hired workers are directed to provide the OFWs with this Advisory.

*Ang mga ahensiyang nagpapaalis ng mga New Hire na manggagawa ay pinapayuhang ipag-bigay alam ang Advisory na ito sa kanilang mga manggagawa.*
